NOTICE OF CONVENTION

Notice is hereby given A Special Convention of the Diocese of Wyoming will be held via zoom on March 2, 2025.

All clergy canonically resident and entitled to vote, and all delegates chosen by each parish and mission are summoned to attend for the purpose of deliberating on the life, the mission, and the ministry of the Episcopal Church in the Diocese of Wyoming.

- Article IV, Sec. 6 of the Constitution, The Ecclesiastical Authority, or the Standing Committee, shall have power to call a special convention, if one is deemed requisite for the good of the Church, provided that no less than sixty (60) days notice be given of the same stating its purpose(s). No other business not directly related shall be transacted. The membership of all special conventions shall be that set forth by canon for an annual Convention.
- Canon 3, Section 2 (b)Every Congregation in union with the Diocese and not in violation of the Constitution and Canons of this Diocese, shall be entitled to send to the Convention as many lay Delegates as permitted by the following:

 The number of lay Delegates shall be based on the average Sunday attendance

The number of lay Delegates shall be based on the average Sunday attendance recorded on the Parochial Report for the year prior to the Convention:

1 to 50 = 2 51 to 100 = 3over 100 = 4

- Canon 3, Sec. 4 (a), "The members of the Episcopal Youth Community of every Congregation may elect one voting delegate who is an Adult Communicant in Good Standing. Such a person must not be over nineteen (19) years of age."
- Canon 3, Section 4 (b), "Episcopal organizations at any of the colleges and universities within the Diocese who have a sponsor approved by the Bishop shall be entitled to one (1) Delegate to be certified to the Secretary of Convention and transferred to the Committee on Credentials for examination and approval."
